

## Vaccine Update 2017

In early 2015 I wrote about the media frenzy surrounding an outbreak of 150 measles cases in our country of 320 million people. Despite the extremely small infection rate (.000047%) and that there have been between zero and 4 deaths directly caused by measles in the US in the last decade (depending on your source), the frenzy of 2015 was used by the legislature and medical establishment in California as leverage to pass a law mandating that children receive the CDC (Centers for Disease Control) vaccine schedule - 49 vaccine doses per child before first grade. Parents in that state can no longer opt out and still send their kids to school or daycare, public or private.

Please remember, public health records are crystal clear on this: measles in this country was reduced by more than 97% before the vaccine was even introduced. Improved sanitation probably deserves nearly all the credit.

More recent data reveals a larger story regarding vaccines. The special Vaccine Court payouts for vaccine damages in the US increased 400% in 2015 from 2014. Payouts for damages caused by the flu shot increased the most, 1000%. Most flu shots still contain mercury. Those that don't typically use formaldehyde as a preservative instead.

On January 7<sup>th</sup> 2017 the medical director of the prestigious Cleveland Clinic Wellness Institute, Daniel Neides, M.D., said that he "took the advice of the CDC and received a flu shot" and that he chose to get the "preservative-free" version, thinking he didn't want any thimerosal (mercury) that the "regular" vaccine contains. Neides was horrified to later learn that the vaccine he received contained formaldehyde.

**Even if you believe that any one vaccine is relatively safe, public health officials have never proven (or attempted to prove) that it is safe to inject infants, children, and teenagers the total volume of vaccines, along with their preservatives and additives, that comprise the current recommended schedule.**

The CDC recommends, and California now mandates, that children receive 35 vaccine doses by the age of 15 months, 49 doses by the age of six, and 69 doses by the age of 18. For perspective, in the late 60s and early 70s US children typically received 7 total vaccine doses, as prevention for 7 diseases, in a total of 3 shots by the time they were about 10 years old.

Vaccines are designed to rev up the immune system. But sometimes over-revving can cause extreme reactions to what should be nearly insignificant stimuli (pollen, dust, peanuts, etc). The Asthma and Allergy Foundation of America states: **since 1980 asthma death rates for US children under 19**



years old has increased by nearly 80%. Could this be from an immune system that is over-reacting due to an onslaught of vaccines? An unbiased scientific study on this specific subject would be very helpful.

Further, mainstream medicine can't explain why, concurrent with a substantial increase in the number of vaccinations, there's been an explosion of neurological issues in American children - soaring autism and ADHD. I've spoken with several long-time public school teachers and administrators who are deeply disturbed by the huge increase in special needs students in the last 20-30 years. Is it purely coincidence this trend has occurred as vaccine use has skyrocketed?

Dr Paul Thomas is a pediatric MD with a practice in Portland Ore. Clinical data from his practice is quite illuminating. **In the thousands of patients he has seen since their infancy, there have been zero cases of autism among children who were**

CDC senior vaccine researcher Dr William Thompson recently revealed results of a CDC clinical trial done in 2001. The trial clearly demonstrated (but never publicly divulged) that administering the MMR (measles, mumps, rubella) vaccine to African American boys according to the CDC schedule (with the first dose between 12 & 18 months of age) creates a 700% greater likelihood of autism compared with administering the first dose after the child is 3 years of age.
